When sending an email, please indicate in the subject line, the agenda item number (i.e., Item No. 2A). Your form/email will be read by the Commission and placed into the item's record at the meeting.

### Provide a Public Comment Live During the Meeting

After logging-in to the WebEx meeting using your computer or device, verify that your audio/microphone is connected.

Once verified, locate the Chat feature in WebEx on your screen.

- In the Chat feature, write: "I would like to speak on Agenda Item #\_\_".

When the Commission Chair calls for public comment on the agenda item, the Virtual Meeting Host will announce your name, then unmute your audio/microphone allowing you to share your comments on the item. You will be heard, but not visible on screen. You will have 3 minutes to provide your comments. When you are finished, your audio/microphone will be muted.
