PROVIDE PUBLIC COMMENT LIVE AT THE MEETING USING ZOOM:

If you wish to speak at the meeting, you will be asked to provide an email address and telephone number to allow the City to email you the Zoom meeting/connection instructions. You can select an audio only connection (telephone call) or connect with audio and video (join the Zoom meeting on your device).

You will receive an email about 1 hour before the meeting with instructions on how to join the meeting.

When connecting to the Zoom meeting to speak, you will be placed in a virtual “waiting area,” with your audio and video disabled, until it is your turn to speak.

As this is a Special Meeting, Public Communications are limited to agenda Items appearing on the Special Meeting Agenda. Individuals may speak for 3 minutes on an agenda topic, with no more than 5 speak time in total for an agenda
