**Narrative:**

On the above date and time detectives with the Ventura Police Department Street Crimes Unit developed information regarding a wanted subject, Robert Reeves, possibly in the 1200 block of Meta St.

Detectives and VPD patrol officers positioned themselves in the area and observed a vehicle, driven by Donald Reyes, arrive and pick up Reeves. As the officers attempted to stop this vehicle it fled at a high rate of speed E/B Main St.

The officers initiated a brief vehicle pursuit but due to the reckless manner in which the vehicle was driving they terminated the pursuit and attempted to keep a visual on the vehicle which continued to the residential area of Channel Dr and Evergreen Dr at which time the officers lost sight of the vehicle.

Officers, detectives, and VPD K-9 officers set up a perimeter and assistance from the Sheriffs Air Support Unit was requested.

At approximately 3:06pm residents on Borchard Dr reported seeing a suspicious male running through yards and was last seen jumping into a backyard in the 2600 block of Ocean Ave.

Officers searched this location and found the suspect driver, Reyes, attempting to hide in the back yard. Reyes was taken into custody without further incident. The vehicle he was driving, a black Chrysler 300 was found abandoned and unoccupied in the 500 block of Rancho Dr.

Detectives continued their investigation and learned that after fleeing Reyes' vehicle on foot Reeves was now possibly hiding at a residence in the 3800 block of Paloma Dr.

Detectives, officers, and VPD K-9 officers responded to this location and located Reeves and a second subject, Rocky Mattley hiding in a converted garage. Both were taken into custody without further incident.

Reyes was later booked on felony pursuit charges as well as a felony warrant. Reeves was later booked on his felony warrant and resisting arrest. Mattley was later booked on his felony warrant and resisting arrest.

Two handguns were located in the garage where Reeves and Mattley were found and additional charges are pending.
