Members should represent arts professions, including artists, educators, or any other type of professional with specialized experience in the fields of cultural arts; education; non-profit organizations; and the Downtown Cultural District business community. No more than three members may be a staff or board member of an organization that competes in the City cultural funding (grants) program.

Two members shall be a landscape architect or licensed architect or design professional such as urban designer, interior designer, graphic designer, building designer, or similar design professional; and one member shall be from the development community such as real estate professional, real estate developer, building contractor, or sign contractor. All members shall be able to read and interpret architectural drawings and evaluate the effects of a proposed building, structure, or sign upon the surrounding community. One of these four members shall serve as an alternate*. These four members shall not be required to be residents of the City, but shall reside within Ventura Water's service area. The terms of these members shall be for four years.</p> <p>*Alternate members shall serve as voting members in the event of the absence of a regular member and shall have the same rights and privileges. In the event of a vacancy on the Commission, the alternate from the appropriate category shall become a regular member of the Commission and a vacancy in the alternate position shall be filled.</p>

Purpose:	The committee will meet quarterly and report to the Finance, Audit & Budget Committee (FAB) on investments to ensure compliance with the City's Investment Policy, propose annual revisions, if needed, and recommend possible investment types/terms. The FAB Committee is the appointing authority. The committee will meet quarterly and provide an annual report to the City Council. The committee consists of the City Manager or designated City employee, Finance & Technology Director/Treasurer, Assistant Finance Director/Deputy Director, and three qualified citizens. Note that the committee is advisory only. All investment decisions are made by the Treasurer/Deputy Treasurer who bears responsibility for them.
