I am informed and understand that participating in the **Corporate Games and related events** involves fitness and athletic activities that can result in personal injury or accidental death. By signing and/or participating, I certify my voluntary assumption of these risks. In consideration of being allowed to participate in the **Corporate Games and related events**, I hereby take action for myself, my executors, administrators, heirs, assigns, successors, and next of kin, as follows:

Waiver/Release: I release, waive, and discharge the City of San Buenaventura, its elected and appointed officials, agents, employees, volunteers and sponsors (collectively "City") from any and all liability, including, but not limited to, that arising from my death, disability, personal injury, and property damage or theft, whether caused by City's negligence or otherwise.

Hold Harmless & Indemnification: I agree to indemnify and hold City harmless from and against all claims, demands, damages or costs, including reasonable attorney's fees, arising from my participation in the **Corporate Games and related events**.

Acknowledgement & Assumption of Risk: I acknowledge that I am solely responsible for my personal health and safety, and the personal property I bring with me. I also acknowledge and accept full and sole responsibility for any medical expenses arising from my participation in the event. I further acknowledge that my participation in the **Corporate Games and related events** is strictly voluntary. I understand that I may discontinue my participation in the **Corporate Games and related events** at any time, at my sole discretion.

Warranty of Good Health: I acknowledge a full understanding of the inherent dangers and risks associated with undertaking any fitness/wellness activity. I warrant that I am in good health, physically sound, and suffering from no condition, impairment, disease, infirmity, or other illness that would prevent me from safely participating in the **Corporate Games and related events**. I have either had a physical examination and have been given a physician's permission to participate in these activities, or I have decided to participate in these activities without the approval of my physician due to no health-related reasons that prelude my safe participation.

I hereby consent to receive medical treatment, which may be deemed advisable in the event of injury, accident and/or illness during the **Corporate Games and related events**.

Severability: I understand that this Waiver and Release is intended to be as broad and inclusive as is permitted by the laws of the State of California and that if any portion is held invalid, void, illegal, or unenforceable in any respect, it is agreed that the balance will continue in full legal force and effect.

Choice of Law: The terms, and rights and duties, of this agreement shall be construed pursuant to and in accordance with the laws of the State of California.

I understand while participating in the **Corporate Games and related events**, I may be photographed. I hereby agree to allow my photographic or video image/likeness to be used for any legitimate purpose by the activity organizers, producers, and sponsors, and their assigns.
