**Line 2 - RENT EXEMPT FROM TRANSIENT OCCUPANCY TAX**

Any exemption from rent must include a filing of the Exemption Claim Form - Transient Occupancy Tax. If the exemption is due to a stay of 30 days, or longer, include a copy of the lease agreement.

If your Transient Occupancy Tax is paid AFTER the Delinquent Date, you must include penalties and interest which shall be calculated as follows:

**Line 5 - PENALTIES**

- 10% of line 4, if filed within 30 days of the Delinquent Date.
- 20% of line 4, if filed more than 30 days after the Delinquent Date.

**Line 6 - INTEREST**

- ½ % of line 4 for each month, including partial month, after the Delinquent Date.

**IMPORTANT NOTES:**

\$0 Rents Collected - You must file this form even if you have not collected any rents for the given month.

Postmark Date - Payment must be postmarked by U.S. Postal Service prior to the Delinquent Date.
