



As a resident of the following streets, you may be eligible to purchase a parking permit. The City's Parking Permit Program provides all day parking for residents on your street by issuing you a permit that will need to be displayed your vehicle; this will allow you to park all day without the worry of receiving a parking ticket. This does not preclude you from not moving your vehicle within 72 hours as the municipal code states.

R Permits *Downtown streets only. No permits to be used on Main St or California St.*

- N & S Fir St (Parking Permit allows holder to be exempt from metered parking on Fir St)
- N Oak St (Parking Permit allows holder to park overnight in N Oak St Parking Lot. Also, a very limited amount of permit holders may be exempt from metered parking on N Oak St)
- S Palm St (Parking Permit allows holder to park overnight in S Palm St/Farmers Market Parking Lot only)
- N Chestnut St (Parking Permit allows holder to park overnight in either N Chestnut St Parking Lots. Also, a very limited amount of permit holders may be exempt from metered parking on N Chestnut St)
- 487 E Main St/Ventura Inn (Parking Permit allows holder to park overnight in N California St parking lot only)
- 373 E Main St/Hamilton Hotel (Parking Permit allows holder to park overnight in N Oak St parking lot only)
- 540 E Santa Clara St/Somerset Apartments (Parking Permit allows holder to park for up to 72 hours in any of the 24-hour parking spaces inside the Downtown Parking Structure only)

S Permits *Has to be with in ¼ mile of the High Schools or the College*

The required proof of residency information on the application shall include a copy of a valid Department of Motor Vehicle Drivers License and the vehicle registration information showing the address of the registered owner.

The cost of the permit is \$20. Permits will need to be renewed every 2 years upon expiration. **No more than three permits will be issued per residential parcel.** Multiple vehicles may be assigned to one hang tag permit so that it may be shared with other vehicles at the residence.

Once the permit has been processed and completed we will contact you to have it picked up.
