PROJECT DESCRIPTION: The proposed LCP Amendment requests the addition of a Zoning Ordinance amendment to Section 24.105.200, "Permitted and prohibited cannabis activities," to allow certain commercial cannabis businesses to operate in certain zones in the City and an additional implementing action that adds Chapter 6.420, "Commercial Cannabis Businesses" to regulate commercial cannabis businesses and mandate these businesses comply with all provisions of the City's Zoning Ordinance, including requirements to obtain Coastal Development Permits, if necessary.

ENVIRONMENTAL STATUS: Preparation of a Local Coastal Program Amendment is statutorily exempt from the California Environmental Quality Act (CEQA) per CEQA Guidelines section 15265.
