Good afternoon City Council Members.

I am writing you today regarding the urgent need for further rental protections for tenants in the city of Ventura. As a worker and a renter in our community I have watched friends, colleagues--all of home are disproportionately from vulnerable communities--and their families be forced out of our beautiful city, one that many of them has been born in.

Housing security in the city of Ventura has been dire for years, and the prices in this city are now higher than that of 95% of the nation. This council has had chances to create housing equity and protections for renters, yet time and again have erred on the side of propping up protections instead for the what-ifs pertaining to the landlord class. How many more families and community members will we be forced to lose because of this council's lack of action on behalf of renters, and their failure to enact an appropriate rental control measure? How long will it be before everyone who does not have the privilege of making \$180,000 or more a year cannot afford our beloved home?

Protect renters as the valuable community members that we are, enact strong and appropriate rental protections for tenants now. Thank you.

-EXT- Covid Funds Allocation - Public Restroom please!

Dear City Council,

Thank you for the following consideration regarding unspent Covid Funds.

I am strongly advocating for Covid Funds to be allocated towards the installation of a public restroom, such as the Portland Loo Restroom, for the Downtown area.

- Public bathrooms are part of necessary infrastructure; and provide essential services for anyone spending time Downtown. Lack of restrooms, not only fail in providing essential services, but also create a public health issue.
 - The need for a public restroom is even more crucial now that everyone traverses Downtown on foot. Trying to find a place where one can access a restroom was difficult before one could drive over to use the city park restrooms, which are sketchy at best and often closed. But now that parking options are further away, it is impossible to access city restrooms quickly, if at all. The hardship is even greater for those with young children or special needs.
- Use of Covid Funds for restrooms is an extension of the Main Street Moves Initiative, which was initially created in response to Covid.
 - Main Street Moves has been overwhelmingly popular; and has done much to improve the Downtown experience. Main Street Moves encourages patrons to spend time Downtown to shop, dine and attend events. But now is the time to follow through with necessary infrastructure to meet the increased demand and foot traffic. Providing more restroom facilities is the natural extension of Main Street Moves. It should not be considered separately, but part of the same initiative.
- The demand for services will only increase.
 - As a Downtown merchant for over 9-years, the number one complaint I've heard from patrons is that there are No Public Restrooms! As a City, we cannot invite patrons downtown, and at the same time ignore their essential needs by not providing access to a clean, safe public restroom. We should not leave it up to the visitors to have to search and beg to use a restroom. Nor should the burden be

- passed on to downtown businesses to provide these essential and public health services. This is City Government responsibility.
- As Ventura increases in population, the demand is only going to grow. While there
 may be plans to build a restroom in conjunction with a new parking lot, a solution is
 needed now. Waiting will only keep the burden on patrons and businesses.

The Portland Loo is a solution worth consideration.

- The public need clean, dignified accommodations. Facilities like the Porland Loo can help meet the need now. It is less expensive than public restrooms, yet safer, cleaner and aesthetically better than a porta-potty. Additionally it allows for members of the LGBTQ+ community, who may prefer unisex bathrooms, access. It accommodates those with disabilities as well.
- When and if, a traditional public restroom is built. The Portland Loo would act as additional facilities during busy weekends and special events. Again, the need is only going grow.

As a Downtown Merchant and a Ventura Resident, I implore you continue the mission of Main Street Moves by allocating unspent Covid Funds toward much needed public restroom facilities.
