

TEMPORARY METER "ON HYDRANT" GUIDELINES

The following documents must be submitted to obtain a Temporary Meter:

- 1. Please complete the Temporary Meter On Hydrant Agreement form and mail or deliver to City Maintenance Yard at 336 Sanjon Rd. Ventura, CA 93002 between the hours of 8:00 a.m. to 5:00 p.m. (note: we are closed alternating Fridays)*
- 2. A copy of your current business license, issued by the City of Ventura*
- 3. A copy of your construction permits or grading permit, issued by the City of Ventura*
- 4. A map with the hydrant location or a photo of the street and hydrant*
- 5. Please make a check in the amount of \$640 payable to the City of Ventura*
- 6. In order to set up a Temporary Meter On Hydrant agent, the company or requestor name on the check must be the same name of the Temporary Meter On Hydrant Agreement form*
 - ▶ The Current Temporary Meter deposit is \$300 and the setting fee is \$340, which is non-refundable) (Checks only) Current daily Temporary Meter rental fee is \$2 plus prevailing water rate of \$5.19 per 100 cubic feet of water used)*
 - ▶ Current Temporary Meter relocation fee is \$113*
 - ▶ If the meter is lost, stolen, or damaged, the company or requestor will be billed for the current cost of a new Temporary Meter*
 - ▶ Once forms are completed and payment received, please allow up to 2-5 business days for Meter to be set Please contact Ventura Water at (805) 652-4500 with any questions*

Temporary Meter On Hydrant Agreement

I authorize Ventura Water to set a Temporary Meter On Hydrant at the location indicated below. I understand that there is a daily rental fee of \$2.00 plus the prevailing water rate per 100 cubic feet of water used. If the temporary meter is lost, stolen or damaged; I understand that I will be billed for the cost of a new meter. Initial _____

I understand that the temporary meters are to be read on the first of the month and I am responsible for the meter being at the location it was originally set. If the meter needs to be moved, I will notify Ventura Water. I understand the temporary meter must only be relocated by an authorized Ventura Water representative and there is a relocation fee of \$113 every time the meter is relocated. If the temporary meter cannot be located for monthly reading, I understand I will be billed for the meter.
