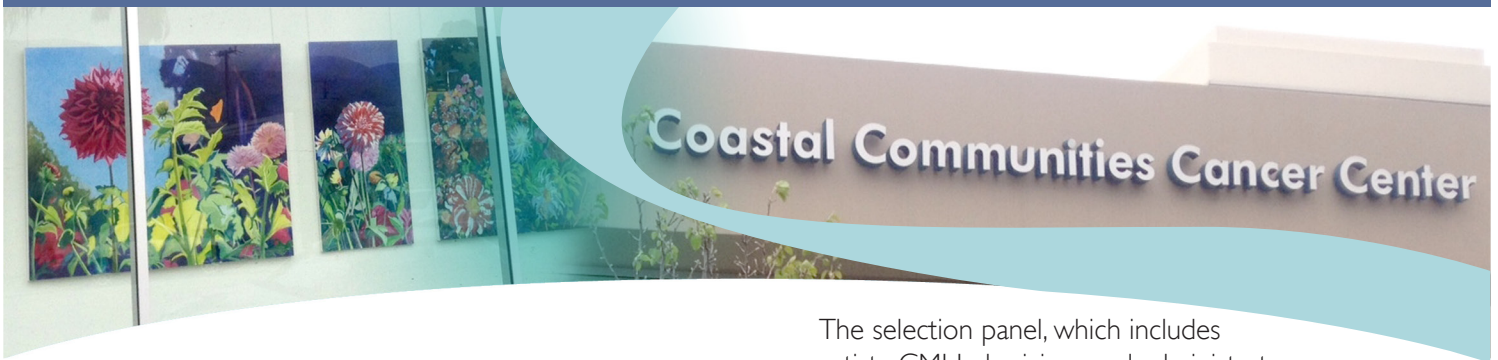


REQUEST FOR PROPOSAL – APPLICATIONS ACCEPTED YEAR ROUND



THE OPPORTUNITY

The City of Ventura Public Art Program in partnership with Community Memorial Hospital invites Ventura County artists to submit proposals to exhibit original art at the Coastal Communities Cancer Center on Loma Vista between Brent and Joanne Streets. The primary goal of the artwork is to share with residents and visiting patients, inspirational qualities of art. Gallery spaces at the facility are situated in the lighted glass windows on three of the exterior walls, each providing an exceptional space for rotating exhibits. Each rotation will exhibit the work of three artists – one for each side of the facility. Selected works will be on display for a period of three months per rotation.

WHAT TO SUBMIT

This opportunity is open to all Ventura County artists whose works are of local interest and contribute to the “*art as inspiration*” intentions of the exhibits. Schools and universities are encouraged to propose exhibits for students and emerging artists. It is not necessary that the work be that of a living artist. Estate pieces will also be considered. Two dimensional and three dimensional exhibits and installations will also be considered.



The selection panel, which includes artists, CMH physicians and administrators, community leaders, and members of the Public Art Commission, will select art based on artistic merit and appropriateness for the specific space.

What to Submit:

- Artist resume and website address
- Brief project description on how your art contributes to the “Art as Inspiration” theme
- 1-10 digital images (jpg files) of artwork to exhibit (either already created works or made-to-request color sketches) at 720-800 x 480-600 pixels
- Each jpg file must meet pixel parameters and be (re)named as the title of the work
- Indicate which window is your preference and include a mock sketch of how you envision your work displayed

THE GALLERIES

On Loma Vista Road – This space is a long open window, offering available space of 48' wide, 12' high, and 15" deep. This gallery space can accommodate two and three-dimensional works (maximum individual size: 9' x 8' long) created from a wide range of media. Some 110 volt outlets are available.

On Joanne Avenue – This gallery space consists of four elevated lighted boxes. Available space for each box is approximately 8' high x 6' wide x 15" deep. This gallery space can accommodate two and three-dimensional works created from a wide range of media.

Parking Lot Façade – Due to *strong sun effects on this side of the building*, artworks involving mosaics, ceramics, fused glass, metal, stone and acrylic or oil on panel will work best here. Artworks involving fabrics, papers and certain plastics may work here as well or even certain works on canvas depending upon the choice of material applied. But no artwork will be considered that is light or heat sensitive such as watercolor, encaustic or many works on canvas. Some 110 volt outlets are available. Heat sensitivity may be a consideration on the Loma Vista and Joanne sides as well.

DELIVERY & INSTALLATION

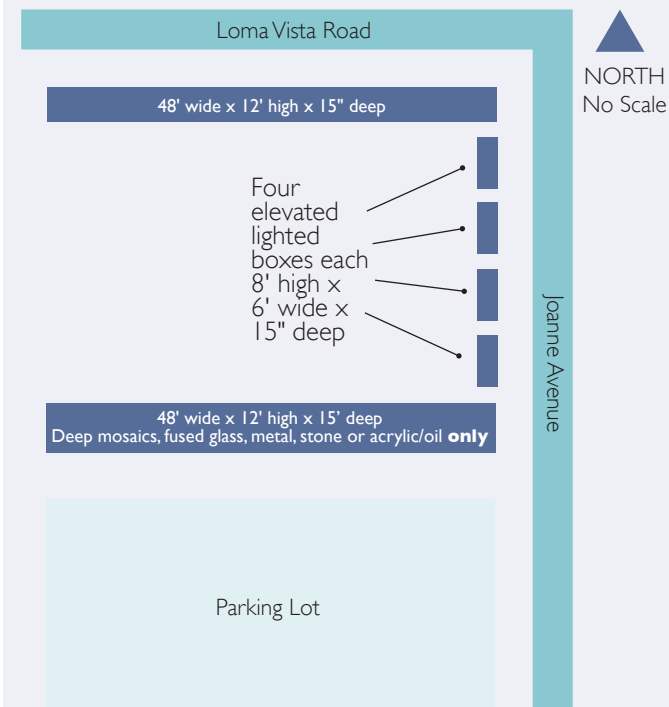

Artist will work with professional installer regarding the preparation of the delivered work and the use of a standardized signage template to insure appropriate space fit and readability from different viewing distances.

The purchase of art is permitted upon completion of the exhibit. All transactions will be handled solely between the artist and the buyer.
