Members should represent arts professions, including artists, educators, or any other type of professional with specialized experience in the fields of cultural arts; education; non-profit organizations; and the Downtown Cultural District business community. No more than three members may be a staff or board member of an organization that competes in the City cultural funding (grants) program.

Two members shall be a landscape architect or licensed architect or design professional such as urban designer, interior designer, graphic designer, building designer, or similar design professional; and one member shall be from the development community such as real estate professional, real estate developer, building contractor, or sign contractor. All members shall be able to read and interpret architectural drawings and evaluate the effects of a proposed building, structure, or sign upon the surrounding community. At least two other members shall also be Planning Commissioners (PC) appointed by the City Council and meet Planning Commission membership qualifications.

The remaining members may be lay people who have demonstrated special interest, competence, experience, or knowledge in the above categories or are residents and property owners within a designated historic district.

Reasonable efforts shall be made to appoint members to the commission whose experience includes all four positions. One of these five members shall serve as an alternate*. These five members shall not be required to be residents of the City. The terms of these five members shall be two years. Four members of the commission shall be persons with a demonstrated special interest, competence, experience in, or knowledge of, the fields of hydrogeology, water and wastewater infrastructure, water resources, or water efficiency. One of these four members shall serve as an alternate*. These four members shall not be required to be residents of the City, but shall reside within Ventura Water's service area. The terms of these members shall be for four years.</p> <p>*Alternate members shall serve as voting members in the event of the absence of a regular member and shall have the same rights and privileges. In the event of a vacancy on the Commission, the alternate from the appropriate category shall become a regular member of the Commission and a vacancy in the alternate position shall be filled.</p>
